4. Candidates applying for the post of Professors and Associate Professors are requested to submit Self-Assessment for the Performance Based Appraisal System (PBAS) in the latest format of UGC.

5. Those who already applied in response to Advertisement No. 04/Rect./BKU/2016 dated 05.07.2016, RO/BKU/M/Rec./01/2017 dated 08.01.2017, RO/BKU/M(R)/19/2018 dated 08.01.2018 and RO/BKU/390/2019 dated 04.08.2019 need not apply again, but they may furnish their updated CV and Self-Assessment for PBAS in the latest format of UGC.

N.B.: Candidates belonging to the OBC-A & OBC-B categories, whose Caste certificates were issued more than one year ago, must produce a ratification certificate from the competent issuing authority that they do not belong to the creamy layer as on date of advertisement along with a copy of the previous certificate to enable this University to decide on the nature of reservation, including SC/ST. The certificate issued by the competent authority within the state of West Bengal shall only be considered valid. Such certificates issued from other states shall not be considered for the purpose of reservation. However, such candidates from other states may apply as unreserved candidates.

If any candidate is recommended for appointment in relaxation of any of the prescribed conditions relating to age, experience etc., it shall be so stated and recorded by the Selection Committee.

Guidelines for latest API calculation

Based on the teacher's self-assessment, API scores are proposed for research and academic contributions. The minimum API scores required for teachers from this category are different for different levels of promotion in universities and colleges. The self-assessment score shall be based on verifiable criteria and shall be finalized by the screening cum evaluation committee for the promotion of Assistant Professor to higher grades and Selection Committee for the promotion of Assistant Professor to Associate Professor and Associate Professor to Professor and for direct recruitment of Associate Professor and Professor.

* Wherever relevant to any specific discipline, the API score for paper in refereed journal would be augmented as follows: (i) paper with impact factor less than 1-by 5 points; (ii) papers with impact factor between 1 and 2 by 10 points; (iii) papers with impact factor between 2 and 5 by 15 points; (iv) papers with impact factor between 5 and 10 by 20 points; (v) papers with impact factor above 10 by 25 points. The API for joint publications shall be calculated in the following manner: of the total score for the relevant category of publication by the concerned teacher, the First and Principal/ corresponding author/supervisor /mentor would share equally 70% of the total points and the remaining 30% would be shared equally by all other authors.
